

## **“Like Our Page To Win” Facebook Competition Terms and Conditions**

### Promoter’s Details

The Promoter is South West Credit Union Co-operative Limited, 117 Lava Street, Warrnambool, Victoria 3280, ABN 44 087 651 705, AFS Licence No 241 258.

### Conditions of entry

The entry to the “Like Our Page To Win” promotion is open only to residents of Victoria over the age of 15 years.

The following persons are not eligible to participate in the promotion:

- c) Residents under 15 years of age
